CHAIRMAN'S FOREWORD

With the continuing impact of Covid, 2021 was another very challenging year for Anam Cara. In 2020, we were forced to move most of our services to an online platform. For an organisation that was very much founded and reliant on face-to-face interaction in providing our supports to bereaved parents, this was a major upheaval and change. We had hoped the change to exclusively online supports would have been short term but Covid had other plans for us.

Despite the challenges, we have continued to support an increasing number of bereaved parents and we believe we have continued to maintain the quality of our support services. It had been one of our strategic objectives to enhance our online supports and Covid has meant that this objective has been realised much more quickly than expected. In addition, we have gradually returned to face to face supports and going forward, we expect that our service delivery will be a hybrid model of face to face and online delivery. We believe that this model will enable us to reach a greater number of bereaved parents, who wish to avail of our supports in different ways.

Meeting the challenges of Covid has been very demanding on our staff, professionals and volunteers and I'd like to express my continuing thanks and admiration for your willingness to adapt and change to meet the evolving needs of a relentless pandemic.

The last couple of years has served to highlight the difficulties of striving to continue to enhance and grow our services with a very small core team. We will need to expand the team, as we expand our services, and this presents funding challenges for us. Although we are in a relatively strong financial position, this can change very quickly without prudent management. Fundraising for all charities is particularly difficult at present with many new demands for support and I'd like to thank our funders for their continuing support, which ensures we can continue to maintain and enhance our services.

I'd like to thank my fellow Directors for continuing to give generously of their time to Anam Cara and we are indebted to Sharon and her team for their continuing efforts in a very challenging year.

2021 was another challenging year for Anam Cara! However, we met that challenge head on and continued to provide information, online resources, support and ultimately hope to bereaved parents throughout the 32 counties. The Covid-19 pandemic and associated restrictions meant Anam Cara could not resume Face-to-Face group events. However, we continued to facilitate online support groups and developed a range of new innovative online support services for bereaved parents. This included a series of Parent Podcasts 'Conversations in Grief' and moving our Bereavement Information Evenings online.

All of this happened with the commitment of our central office team, professional facilitators, and volunteer parents to whom we are indebted for their dedication in what was challenging times for them too.

Anam Cara will not underestimate the ongoing impact of grief, isolation and loss parents are enduring, which has intensified due to the pandemic. Bereaved mothers and fathers will continue to be our priority throughout 2022.

Anam Cara's focus will remain on continuous improvement and best practice as well as growing awareness of our services in the communities across the 32 counties. We will continue to collaborate with front-line healthcare professionals and other organisations in contact with bereaved families to ensure the best use of resources and funding.

As I step away from the CEO role, I would like to express my deep gratitude to Chairs and board of directors I have worked with since 2009. Each one of you playing a special role in shaping the organisation Anam Cara is today. I also want to thank the parents I have met and worked with along my journey who inspire me each day.

A very special thanks must go to the central office team who have worked tirelessly over the past two years to ensure the continuation and growth of Anam Cara's support services.





ABOUT ANAM CARA

THE NEED

Each year throughout the island of Ireland, about 2,650 families will experience the sudden or expected death of a son or daughter (aged 0-44yrs). This is the ultimate tragedy faced by parents. Alongside the devastating grief, many parents experience feelings of isolation, despair and very often loneliness. Some bereaved parents report that they self-isolate as they cannot face meeting people or continue living a normal life when their child cannot.

Sadly, self-isolation is not the only issue faced by bereaved parents. Many feel that friends, neighbours and sometimes extended family avoid them. This may be due to people not knowing what to say to a bereaved parent which unintentionally causes more upset to the devastated parent. This social exclusion has a serious knock on effect on the bereaved parent's self-esteem, confidence and mental health causing them to become more isolated.

THE RESPONSE

To respond to this need Anam Cara, an all-Island organisation, was founded in 2008 by bereaved parents to ensure that all bereaved families in Ireland will have access to information and support following the death of their child.

We provide a wide range of bereavement support services, peer support and understanding to parents who have experienced the death of a child. Anam Cara's online and face-to-face services are available to all parents regardless of the age or circumstances of the child's death and are available for as long as the parents require them.

Anam Cara is unique. There is no other service like us in Ireland. We provide a level of support and understanding that other service providers cannot offer, as our bereavement as parents unites us.

We know and understand what a recently bereaved parent is going through, therefore, we can offer peer support which is hugely beneficial and comforting to parents. We focus on the similarities of our loss rather than the differences and have found a level of support and understanding that others cannot offer.

OUR MISSION

Anam Cara will make a difference and reduce isolation for bereaved families affected by the death of a child or children, regardless of the age of the child or circumstances of death.

Anam Cara will do this by providing easily accessible, quality support services, signposting and information through safe and secure online or face-to-face environments.

OUR PURPOSE

Anam Cara provides a lifeline to parents through our on-line and face-to-face peer support services.

OUR VISION

Every family throughout Ireland will have the relevant support services they need following the death of their son or daughter.

Without the support of our wonderful volunteers the work and services Anam Cara provide would not be possible.

Our volunteer parents who are bereaved themselves understand the devastation and grief recently bereaved parents are experiencing and volunteer their support and gentle presence at group meetings in reaching out as they start their own journey of grief.

They have undertaken the learnings and skills of adapting services online during the pandemic and we thank them for their dedication, patience and commitment to Anam Cara during this period. As well as our volunteer parents we have many others who have provided support through the year and we would like to take this opportunity to say a huge thanks to each and everyone of you for your time and kindness during another very challenging year.

OUR SERVICES

Anam Car has 12 established groups around the island of Ireland and currently working on the opening of 2 new venues: South East and the Midlands. Our commitment is to provide accessible and appropriate information , resources and peer support to parents who have experienced the death of a child.

Anam Cara was set up in 2008 due to the lack of services available for bereaved parents and since then has forged strong links with other frontline organisations and professionals in contact with bereaved parents. This ensures the best use of resources and avoids duplication of services in the communities.

We believe Anam Cara provides a unique model of group support through our volunteer parent and professional facilitator roles. There is no other bereavement support service like us in Ireland as we continue to provide a level of support and understanding that other service providers cannot offer.

Our service users are at the forefront of our services and we listen, take on board all feedback and make changes to our services to ensure we are meeting their needs. We will continue to do this and strive for best practice around everything we do.

Our commitment to good governance, training and development along with continuous improvement have been key factors in ensuring Anam Cara continues to be the organisation that bereaved parents can trust to provide them with appropriate information and support in 2019.

Anam Cara understands that the death of a child, of any age, is a life changing event for parents and surviving siblings. It is not just the absence of their child's physical presence that parents grieve, they also grieve for the future, the many milestones and family events they are missing. For that reason Anam Cara's support services are available to parents for as long as they need them.

Bereavement Information Evenings provide bereaved parents with an opportunity to hear an experienced mental health professional discuss parental grief and the challenges parents face after the death of a child. For those whose child suddenly dies outside a hospital/hospice setting, including from suicide, this is often their first encounter with any form of bereavement support.

Anam Cara Parent Groups meet monthly in a safe and comfortable setting. These groups are led by a Professional Facilitator and Volunteer Parent who ensure the evening runs in accordance with Anam Cara's Core Values. Newly bereaved parents can connect with parents further along their journey. Hearing how they have coped through the early months of grief, gives them hope they too will survive the tragic death of their child. During the pandemic we offered our support groups online and have continued to offer a hybrid support structure.

Anam Cara Bereavement Support Workshops for parents living with no surviving children. They provide a safe and comfortable forum for parents to meet with other parents who understand the grief, milestones and challenges that follow the death of your only child or children. These ½ day workshops currently take place in a central location about 4 – 5 times a year

Our Family Remembrance Events give families, including siblings, an opportunity to remember, with others who understand the impact of grief and the adjustments it takes to find the resilience and strength to cope. These events allow families to remember their loved one in a meaningful way.

Anam Cara's Website is updated regularly with information for parents and includes 5 professional videos, webinars and links to other organisations who provide information and support to bereaved parents.

Bereavement Information Pack includes 8 leaflets for bereaved families, including A Mother's grief, A Dad's Grief, Coping after the Sudden Death of your Child, Milestones and Challenges, Self Care, Supporting My Family, Adults grieving the death of a brother or sister, Living with no surviving children.

Excellent **Support Network** available to parents at no cost and for as long as it is needed. In addition, we link families with other relevant supports and organisations in their community resulting in an excellent working relationship with these service providers.

Frontline Professional training – available to those who may be first point of contact to a bereaved parent i.e.: the Gardaí, the PSNI, social care workers and funeral directors. Providing training in how to support a parent following a sudden death or accident.

ACTIVITIES IN 2021 ADAPTING TO THE PANDEMIC

Having endured 2020 with lockdown and restrictions, we had hoped that the Pandemic would be well behind us, but as we headed into 2021 nothing seemed to have changed and we continued providing our services online. One positive factor going online was the opportunity to extend our reach to bereaved parents who perhaps due to circumstances or geographical challenges had not previously being able to access support, and we noticed an increase in families connecting with us.

2021 was a challenging year by all accounts, but our main focus was on the continuance of delivering our services to parents the best way possible, ensuring that no one felt isolated or without support.



Webinars

Anam Cara ran 2 sets of 6 webinars in both April and November over 6 week periods.

These were facilitated by Brid Carroll a qualified Psychotherapist and Counselling Supervisor who has a special interest in loss and bereavement issues with a wealth of experience.

Topics covering all aspects of one's journey of grief, touching on the unique meaning of having lost a child, what are the key influences of grief, and how we grieve so differently.

Group Meetings

Restrictions prevented most of 2021's face to face meetings to be cancelled. Having being introduced to online Anam Cara continued to develop their online supports and ran monthly group meetings by zoom, facilitated by professional facilitators. This ensured that the established groups of parents attending our services were not left unsupported during this period and still had the opportunity to tap into the peer support they had come to rely on.



Extra supports

For many Covid brought on extra stress, isolation and reduced coping mechanisms. To support those who needed a little extra help during this period Anam Cara provided 1 - 1 support calls with one of our Professional facilitators., where they were able to share their feelings, thoughts and challenges in a confidential environment. For a few these challenges were escalated and for those individuals Anam Cara supported a level 3 counselling service free of charge.

Remembrance Day

Our Remembrance Day for 2021 was held on 6th November, where a specially designed webpage was created to remember and honour our children in a special way. Parents had the opportunity to send in their personal messages to be included on the online Remembrance Day book. In Anam Cara we understand the intense grief, loss and loneliness every parent faces after the loss of a precious child. This day brought parents together to unite in their grief and light a candle, pause for a while and listen to 'The Dance' performed by Aidan & Joyce Murphy, a song chosen specifically to connect the 202 parents who linked in on the day.



Professional Frontline Training

Following the demand of our pilot training workshop to Professional frontline workers in 2020, Anam Cara held 4 further online workshops during 2021.

The purpose of the workshops were to expand the understanding of how traumatic events and bereavement can affect people and to enhance their knowledge and skills in how best to support bereaved families through their work and within their communities. Facilitated by both Brid Carroll counsellor and psychotherapist & David Hickey, a clinical psychologist and trauma specialist.

Bereavement Information Evenings

In 2021 Bereavement Information Evenings became a high priority, with so many parents stuck in lock-down and looking for information on how to address the challenges they were facing and little support coming from anywhere, these evenings were critical.

Professional guest speakers spoke on the effects of trauma, PTSD, challenges on learning how to accommodate grief, supporting spouses, partners and extended family through the various milestones they face.



A PARENT'S REFLECTION ON THE ESSENCE OF ANAM CARA

"From the very first phone call to Anam Cara, you will feel so many emotions...of being truly listened to & of being understood. It feels like already some of the weight is lifted from your shoulders because you can actually feel the empathy and kindness at the end of the line.

To be asked about your child, his or her name, you'll feel listened to, cared for & that your child matters not just to you, but who's name can be acknowledged & spoken of with people who really care. Family & friends are so kind, but unless they have personally lost a child, they don't understand what we're going through.

The wonderful, caring people in Anam Cara will link you up to a parent bereavement group, which isn't as scary as it sounds. It's just some parents who have lost their child too, from infancy to adulthood, it doesn't matter what age, or how, because all of us parents share one common bond, we know & understand your pain.

There's a feeling of "freedom" at these meetings. Everything is explained at the beginning of each session. Confidentiality is paramount, & what is shared within the session with other parents, stays there. You will be able to be yourself, & no matter how you are feeling at that very moment, you will never, ever be judged, or worry about it being discussed with other people. We are all in this together, & believe me, we all need this safe space to say what we feel without having to explain our feelings, because you'll be with people who know exactly how you're feeling.

At times when you're struggling to put into words how you're feeling, don't worry about that either ..its understood nevertheless. Anam Cara is still our lifeline 3 years down the road. Yes, the first time you walk into an unknown group of people when you are raw and completely distraught having lost your child is underiably daunting, everyone in Anam Cara understands this.

You might be a bit surprised to find at first that there are parents greeting each other with light hearted conversations and even jokes, but you'll also sense that you're coming into a lovely warm welcoming space. You needn't feel pressurised to speak, and might feel safer and more content just to listen to other bereaved parents' experiences."

ANAM CARA NORTHERN IRELAND

Anam Cara in Northern Ireland has been established on the same premise as Anam Cara for the rest of the Island. Board membership in Northern Ireland includes Sharon Vard, Jarlath Corrigan, Kevin McCallion, Heather Wells, Anne-Marie McClure and Michael Scott.

Work continues with the Northern Ireland's Children's Hospice.

Communications, in the form of press releases, were issued in 2021 to raise awareness of Anam Cara and the groups in Belfast and Armagh in particular. Open Strategic Communications continues to support the group on an ongoing and on a pro-bono basis. When possible, we will work to secure structured links to the undertaker network in Northern Ireland.

The Armagh and Belfast groups continued to meet monthly. These meetings were face-to-face until the restrictions due to COVID-19 meant that this was no longer possible. The support meetings were then brought online. Kate Dornan, facilitator with the Belfast group facilitated a combined group for all bereaved parents in Northern Ireland, and although the ideal setting for the support groups is face-to-face, during the very uncertain times we faced, the online meetings were appreciated and well supported. Last year we also welcomed our new facilitator to the Armagh Group, Nuala Gorman.

Work is ongoing to develop and expand the number of Volunteer Parents. In the future, efforts will be made to consider expanding the offering of Parent Support Groups within Enniskillen, Ballymoney or possibly the wider Newry area. Siblings support and a wider reach in Belfast will also be a key focus for Northern Ireland in 2022.

I'd like to thank my fellow Board members, the Board and Staff at Anam Cara Dublin office, our facilitators and volunteer parents for their continued hard work and for making it possible to continue to provide our services across the island.

Finally, I would like to especially thank Sharon Vard who has stepped down from the Northern Ireland board. Thankfully, Sharon continues to do great work within Anam Cara. Without Sharon and the founding committee who were instrumental in Anam Cara's formation, we would not have been in a position to support those many bereaved families over the years.

OUR STRATEGY

Anam Cara was officially launched in 2008. The main focus of the first eight years was to build support systems and to develop the services including the geographic expansion across the island of Ireland, while maintaining service quality.

There has been a very strong growing focus on governance, particularly relating to the development of best practice, with the drafting and implementation of policies and protocols to safeguard all stakeholders, especially parents and volunteers.

Anam Cara has ensured that all bereaved parents can access appropriate quality support and information, free of charge, and we remain committed to achieving this goal even as the need for our services continues to rise.

In August 2019, we commenced the development of our fourth strategic plan with UpThink Innovation agency. The aim was to review the existing plan and objectives and reflect on what direction and focus to take for our journey to 2022.

2020 was a year like no other due to the COVID-19 pandemic. A year that started off with big plans for the organisation was brought to a crashing halt in March 2020. Moving into 2021 we thought we would be seeing an end to restrictions and the pandemic, however little did we know that a full year with the implications of this virus lay ahead.

Despite the challenges that Covid 19 threw our way Anam Cara had the ability to remain on track in following our strategic goals. Having moved services quickly online to support parents through this period, and adhering to our 1st strategic goal to expand our reach we looked at how we could adapt and develop other services to the wider community.

Strategic Goal #2: to put in place the succession plans for key executive roles. Late 2021 saw the commencement of interviews to recruit a new CEO when Sharon Vard will step into the role of Services Manager commencing Jan 2022.

Following our Strategic goal #4 in creating awareness of the Anam Cara brand we continued in developing training workshops for Frontline Professionals. Through these workshops our brand and training was delivered to a variety of organisations and individuals including social workers, funeral directors, gardai and PSNI family liaison officers.

Our Strategic goal #5 in collaborating with local partnerships saw Anam Cara run two bereavement information evenings in association with Northern Ireland Children's Hospice, facilitated by psychotherapist Brid Carroll. These events enable us to share our resources and reduce costs.

OUR STRATEGY

Our Volunteer Parents and Professional Facilitators are key to the professional services provided by Anam Cara and recognising their commitment to the organisation we continue to develop and provide a bespoke training programme to support them in their roles.

To conclude, to all who contribute to our organisation, our board, the central office team, professionals, key funders and donors a huge thank you, Anam Cara could not do what we do for bereaved parents were it not for each of us playing our part.

OUR STRATEGIC GOALS 2020- 2022

Strategic Goal 1

Evaluate our business model options to allow us expand our reach, develop new services, explore education and research, build on partnerships and evaluate new delivery mechanisms.

Strategic Goal 5

Expand our reach through the development of local partnerships and collaborations with similar organisations that have aligned values, creating better outcomes for bereaved parents and their families.

Strategic Goal 6

Review our delivery channels and how we connect and new methods of delivery including online as a means of support.

Strategic Goal 7

Capture and document Anam Cara's domain expertise, evidence, data and knowledge. Expand research both domestically and internationally to share our thought leadership.

Funding 2021

2021 was a challenging year on the funding front for all charities and Anam Cara was no exception, but thanks to the wonderful support we received from volunteers who ran events on our behalf, donations and grant recipients we maintained costs to a minimum and were able to continue to provide our services to ensure all our bereaved parents were supported during the pandemic when restrictions were in place.




